The card lists the establishment number; the employee number; the employee's name, address, occupation, age, and gender; the employee's rate of pay, weekly earnings, and annual earnings; and the weeks, days, and hours the employee worked during the year commencing September 26, 1912. During the fifty-two weeks he worked during the year, Mr. Swiegal earned an average of \$12.82 per week at the rate of \$13.00 for a sixty-hour week.
