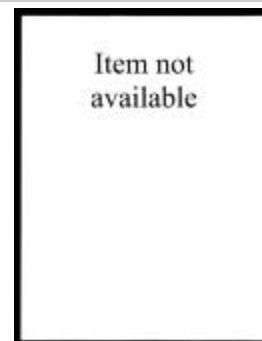

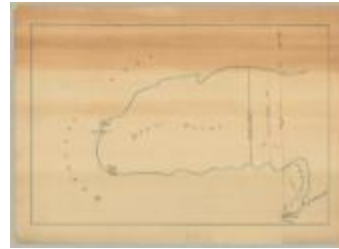

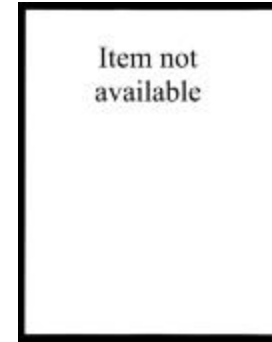

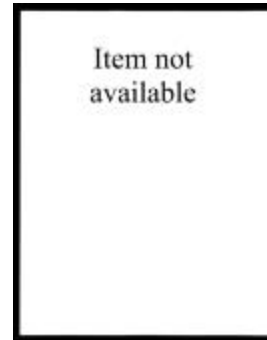

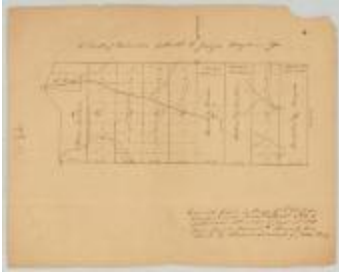


Map of Long Point on Lake George. Warren

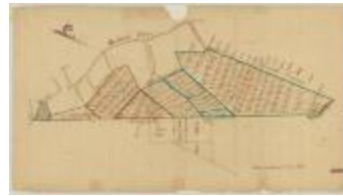


Map of lands adjoining Lake George near

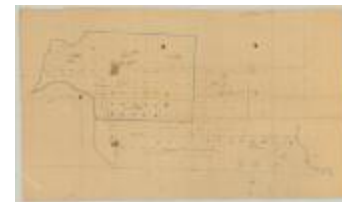

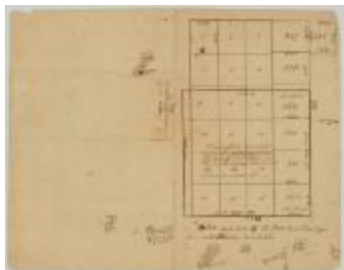

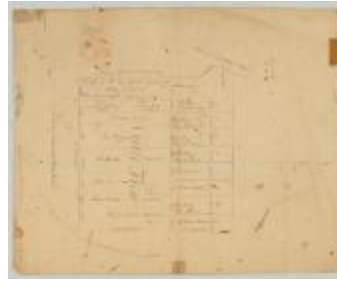

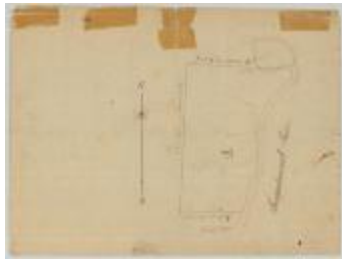

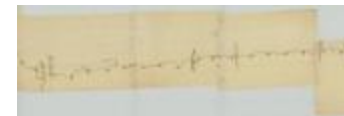

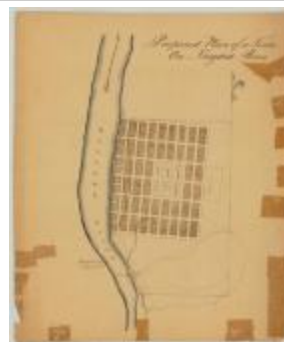

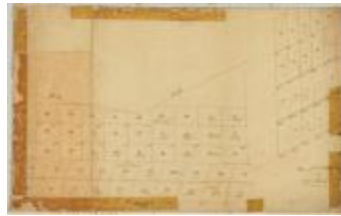

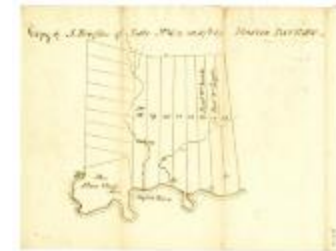

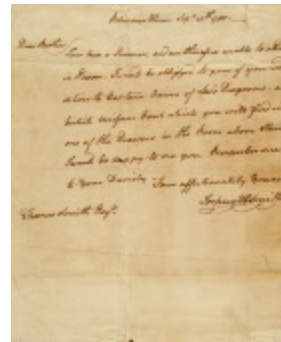

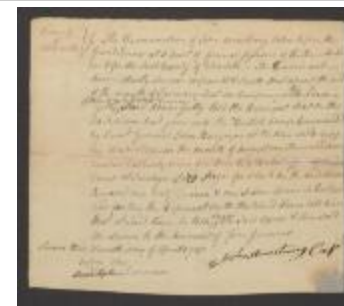

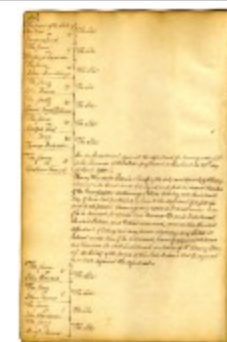
