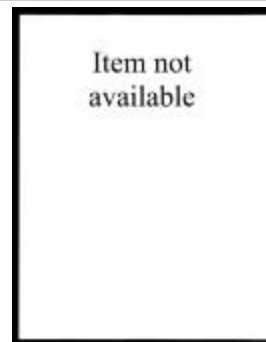

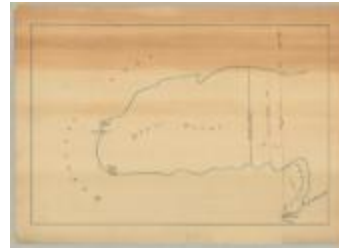

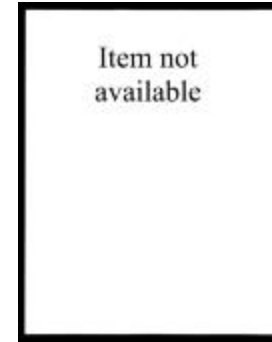

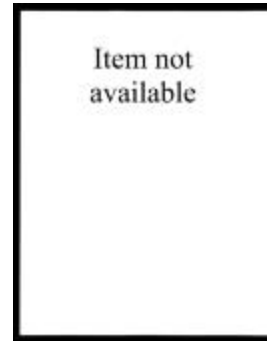

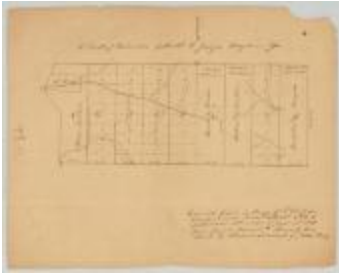

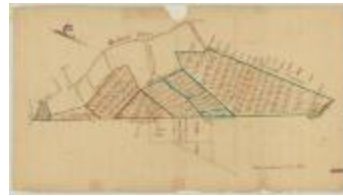
Map of Long Point on Lake George. Warren

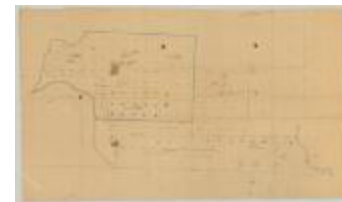

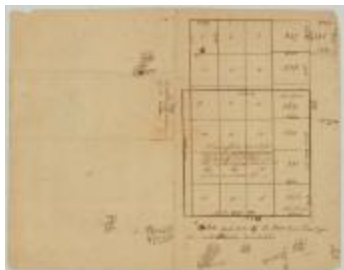

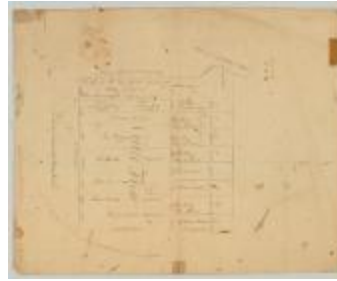

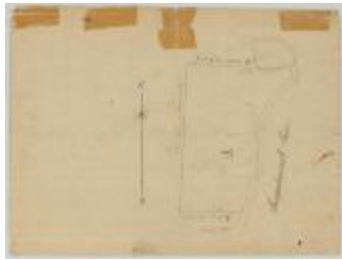

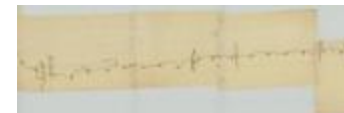

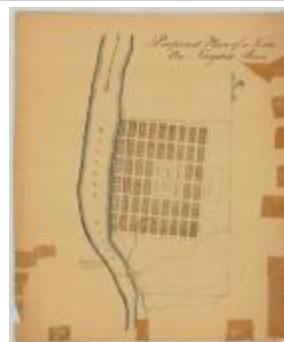

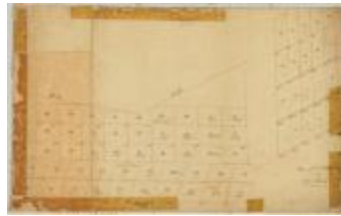
