IN SENATE — Introduced by COMMITTEE ON AGING — (at request of the Governor) — read twice and referred printed, and when referred to be committed to the Committee on Finance

IN ASSEMBLY — Introduced by COMMITTEE ON RULES — (at request of the Governor) — read once and referred to the Committee on Ways and Means

AN ACT to amend the public health law, in relation to the transfer of funds to general care centers facilities; and to amend chapter 1 of the laws of 1989, relating to the New York Health Care Safety Act of 2000, in relation to the various options and initiatives; and to amend chapter 105 of the laws of 1994, relating to certain provisions related to the 1994-95 state operations; and to amend chapter 100 of the laws of 1994, relating to extending the effectiveness of certain provisions thereof; to amend chapter 10 of the laws of 1994, amending the social services law relating to limiting the method of payment for prescription drugs under the medical assistance program; in relation to the effectiveness of such chapter to amend chapter 113 of the laws of 1997, relating to amending the department of health to establish certain programs for general hospitals; in relation to extending the authorization to acquire such property; to amend chapter 102 of the laws of 1998 amending the real property tax law and other laws relating to improving the administration of the school tax relief (STAR) program; in relation to extending the effectiveness of certain provisions thereof; to authorize the comptroller to issue warrants to various funds for a certain period; to authorize the comptroller to continue to receive moneys due deposits to the credit of various funds and accounts for a certain period; and to authorize the comptroller to pay prior year liabilities for a certain period
