IN SENATE -- A SENATE BILL, SUBMITTED BY THE GOVERNOR PURSUANT TO ARTICLE IV OF THE CONSTITUTION -- read twice and ordered printed, and when printed to be committed to the Committee on Finance -- committee discharged, bill amended, ordered reprinted as amended and recommitted to said committee -- committee discharged, bill passed, ordered reprinted as amended and recommitted to said committee -- reported favorably from said committee, ordered on a third reading, passed by Senate and delivered to the Assembly, read, vote reconsidered, returned to third reading, amended by inserting to previous point 2.6202 -- again amended and ordered reprinted, retaining its place in the order of third reading

IN ASSEMBLY -- A HOUSE BILL, SUBMITTED PURSUANT TO ARTICLE IV OF THE CONSTITUTION -- read twice and referred to the Committee on Ways and Means -- committee discharged, bill amended, ordered reprinted as amended and recommitted to said committee -- reported and referred to the Committee on Rules -- passed by Assembly and delivered to the Senate, read, vote reconsidered, ordered reprinted, retaining its place in the special order of third reading
