AN ACT concerning the sentencing reform act of 1995 to amend the penal
law, the correction law, the criminal procedure law and the executive
law, to require the providing for the sentencing of juvenile delinquents
of minors to amend the constitution to amend the articles of the
sentencing reform act of 1995; to amend chapter 896 of the laws of
1995 amending the correction law and the penal law relating to prison
of forfeiture of certain assets and the crime of sentencing, including
to amend chapter 361 of the laws of 1995, amending chapter 50, 51 and
56 of the laws of 1995, the correction law, the penal law and other
chapters and laws relating to correctional facilities to amend chap-
ter 55 of the laws of 1995, amending the law and other laws relat-
ing to laws, rules, regulations, fees and funding to amend chapter 339 of
the laws of 1995, amending the correction law and the penal law relat-
ing to inmate work release, law suits and laws to amend chapter 40 of
the laws of 1994 relating to the state, the correction law, the executive law
relating to sentencing and conviction of minors, including laws
relating to certain drug-related offenses, in addition to reporting
requirements and the effective date thereof, and to repeal certain
provisions upon the expiration thereof
