I, RICHARD E. MOOT, counsel for the defendant, WINCENT

difficulties in order to determine the amount of additional time
necessary to complete the work. I was accompanied on this visit
and at this conference by Mrs. Eleanor H. Ringer who had been
employed on behalf of all the Defendants to organize and direct
this work.
