I, RICHARD E. MOOT, counsel for Defendant Vincent R. Mancusi, make this affirmation in opposition to plaintiffs' Motion for Recusal and in further support of Defendant Mancusi's pending motions to dismiss. Filed with this affirmation is a legal memorandum on behalf of Defendant Mancusi setting forth the legal authorities and arguments in opposition to plaintiffs' Motion for Recusal.

In addition to the legal insufficiency of the grounds stated by the plaintiffs in support of their Motion for Recusal, it is apparent from the history of this case that recusal of the trial judge, Honorable John T. Egan, who has presided over the matter since April 9, 1973 when the action was transferred from the Southern District of New York to this District, will require a great deal of additional work on the part of any new judge assigned to the case before the case can be retried. In order to become familiar with the matter, the status of pleadings and parties must be determined. It is unlikely the parties will agree which of the existing
